### Proposal for the upcoming levy:

- ♦ **1% Earned Income Tax Rate**

*As opposed to an 8.67  
Equivalent Property Tax*

- ♦ **Tax is on Earned Income only**

- ♦ **Funds to be used for the  
purpose of current expenses**

*General operating costs:  
personnel, utilities, and supplies*

- ♦ **Estimated \$1,700,000 to  
be generated per year**

- ♦ Interest, Dividends, Capital Gains

**These types of income will NOT BE TAXED.**

## **Taxable Earned Income is simply:**

- ♦ Wages, salaries, tips, and other taxable employee pay
